Please Note: Due to the legal requirements and procedures required for the approval of a variance or special use permit, **it is required** that applicants discuss the application and review process with a city planner prior to submitting an application at least 48 hours prior to the application deadline. *State of Iowa law requires that all property owners within 250 feet of a property for which a variance has been requested be notified of the request and the date and time of the meeting at which the request will be considered (city staff typically extend the notification radius to at least 320 feet). Notice must also be published in a local periodical - the City of Johnston typically publishes in the Des Moines Register.
